# **Scale in context:**

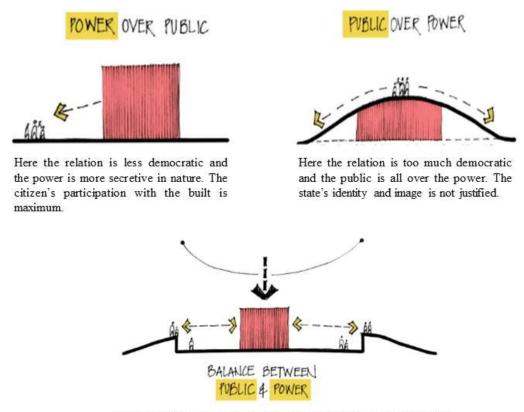
The simplest way to communicate the most fundamental concepts, such as power or weakness, is through scale. Buildings' scale reveals the order of importance in a given situation.

- · Compatibility with surroundings: greater contrast results in greater distance and oddity

The Capitol Assembly gives a sensory experience through a variety of vistas by using circulation patterns as a form of narrative trip.

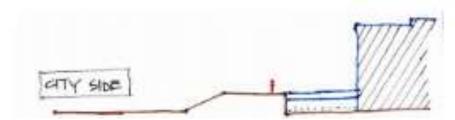


Figure 2 Dhaka Parliament : The interaction of public with the parliament building seems not very participatory. the scale of the building is also very dominating.

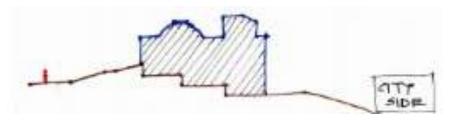


Figure 3 Vidhan Bhavan Bhopal : The buildings sits on a hilly site and the public entry into the building is from the topmost side of the hill. It depicts that the building overlooks city.

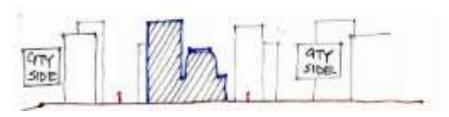


Figure 4 Vidhan Bhavan Mumbai : The building is very consolidated and is part of Mumbai's high rise locality near the Nariman Point. The building is highly secured and isolated.

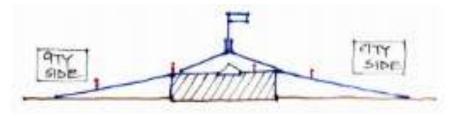


Figure 5 Parliament Canberra: This building could be seen as more democratic in nature. The interaction of the building with the public is such that the public can access the building.
